2016/2017 Kids Recreation Fund Guidelines

Who is eligible to apply?

Children and youth, aged 0 to 18, who are residents of the Yukon, and whose family combined household net income is under:

- \$40,500 with 1 child
- \$46,500 with 2 children
- \$52,500 with 3 children
- \$58,500 with 4 or more children

What can be funded through the KRF?

The KRF helps cover the cost of sport and recreational registration fees including camps, memberships and lessons, supplies, and sport-specific equipment (see below for a complete list of eligible equipment). A maximum of **\$500 per child** is available from the KRF per fiscal year; **\$400 is available for equipment and programs/registrations, plus an additional \$100 is available for programs/registrations only.**

Equipment funded by KRF:

- ✓ Bikes (**only funded every 2 years**), bike locks, helmets, pumps, child carriers/trailers (**only funded once per family**)
- ✓ Balls - soccer, volley, basket, soft, base, foot, tennis, table tennis, squash
- ✓ Fishing rods, frisbees, kites, skipping ropes, hockey sticks, pucks, street hockey balls, nets
- ✓ Ice skates, roller blades, roller skates
- ✓ Long boards, skateboards, scooters (**each only funded every 2 years**)
- ✓ Jungle gym/swing set (**only funded once per family**)
- ✓ Trampolines (**only funded once per family**), trampoline enclosures, trampoline covers
- ✓ Racquets – badminton (and birdies), squash, tennis, table tennis paddles
- ✓ Snowboards, cross country and downhill skis, bindings, boots, poles
- ✓ Strollers (**only funded every 2 years**), wagons, tobogganing sleds (including crazy carpets, GTs, etc.)
- ✓ Protective sport's gear – helmets, pads (shin, elbow, knee, chest, shoulder), protective eye wear, sport specific gloves (batting gloves, hockey gloves), ankle braces, jockstraps, mouth guards, lifejackets, water-wings

Equipment NOT FUNDED by KRF:

- x Ammunition and weapons of any kind (air rifles, bows, arrows, pellet guns, darts, knives, etc.)
- x Board games, video games
- x Camping equipment (tents, sleeping bags, foamies, cookware, backpacks, etc.)
- x Clothing (winter/outer clothes, street clothes, hats, hiking/winter boots, street shoes)
- x Car seats
- x Play houses, sand boxes
- x Pools of any kind, canoes, rafts, paddles, fishing lures, tackle boxes
- x Toys

Other equipment may be funded with proof of child's registration in program specifically related to that equipment. Contact Sport Yukon to inquire.

When is the deadline to apply?

Applications will be accepted from April 11th, 2016 until March 31st, 2017. After March 31st, no applications will be accepted.

What is the processing time?

Applications require up to 14 days to process from the time all the correct information is submitted. Applicants will be notified by phone or email once their application has been processed.

How to apply:

1. For equipment: get quotes from the local store(s) you are seeking equipment from or, if you purchase the equipment yourself, bring in the original receipt (no older than 3 months from date of application). Online purchases must be paid for at time of the order and may be reimbursed with a receipt. Make sure the equipment you are seeking is on the list of eligible equipment for funding (see above).
For programs: if you can, apply for program first. Bring proof of registration (receipt or proof of enrollment in program, camp, sport, etc.) or an info sheet about the activity that shows its price (blank registration form, brochure, etc.) in with application.
2. Fill out a separate KRF application form for each child you are applying for.
3. Provide proof of eligibility for the KRF as listed on the application form (this is only required once per KRF year).

Examples of proof of marital: tax return summary showing marital status; T1 General Form; a letter from your landlord, employer, social/support work, lawyer, accountant, or tax preparer validating your marital status.
