# Athlete Participation Fund Guidelines

## 2019/2020 Application Form

April 8, 2019 to March 13, 2020

### Funding Use

The Athlete Participation Fund is a time-limited fund designed to support low-income families with:

- Participant costs for Territorial Sport Organization representative team travel outside the Yukon
- Team Yukon participation fees for Canada Summer/Winter Games, North American Indigenous Games, Western Canada Summer Games, or Arctic Winter Games

A maximum of \$500 per youth is available each fiscal year under the Athlete Participation Fund.

### Who is eligible to apply?

Funding is available for Yukon youth, aged 18 years and younger, whose family combined household net income is under:

- \$43,900 with 1 child
- \$50,300 with 2 children
- \$56,700 with 3 children
- \$62,500 with 4 or more children

### Required Eligibility Documents:

**Proof of income:** examples – 2018 Revenue Canada Notice of Assessment, 2018 Canada Child Benefit Statement, recent Social Assistance Budget Sheet.

**Proof of marital status:** examples -

*Married & Common law: 2018 Revenue Canada Notice of Assessment of both individuals.*

*Single, divorced, separated, widowed: Tax return summary showing marital status; T1 General Form showing marital status; CRA Marital Status, a letter from your landlord, employer, social/support work, lawyer, or tax preparer validating your marital status.*

**Proof of child's dependency:** examples - birth certificate, identification card, 2018 Canada Child Benefit Statement, letter from social worker, teacher or principal

If you have already received funding through the KRF in this fiscal year, you are pre-approved for the Athlete Participation Fund.

### Application Deadline

Applications will be accepted until March 13, 2020.

### Restrictions

Applications for funding must be made at least two weeks prior to travel. Applications submitted after the time of travel will not be considered.

Proof of the athlete's participation (e.g., a photo of the scorecard with the athlete's name on it) must be submitted within two weeks of return travel. Insufficient proof of participation will disqualify this application.

*As part of the Lotteries Yukon 40<sup>th</sup> anniversary celebrations, the Yukon Lottery Commission made a one-time contribution of \$100,000 to Sport Yukon to assist low-income families; funding for this program is through this one-time contribution.*
